Market volume refers to the total number of cars sold in a year, while market value is calculated by multiplying the average retail selling price with the market volume.
- The South African new cars market recorded revenues of \$8.4 billion in 2023, representing a compound annual growth rate (CAGR) of 4.0% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 3.9% between 2018 and 2023, to reach a total of 344.5 thousand units in 2023.
- According to GlobalData, in 2023, the volume of new cars sold in South Africa experienced an annual contraction of 31.7%. This market contraction is attributed to the decline in disposable income which reduced consumer purchasing power making new vehicle purchases less affordable.
