- Market consumption volumes declined with a negative CAGR of 1.1% between 2018 and 2023 to reach a total of 467.6 thousand units in 2023.
- According to GlobalData, in 2023, the revenue of the Thai new cars market recorded an annual growth of 12.2%, rebounding from a historic downturn. The growth is primarily driven by the increasing consumer demand for higher-end vehicles, enhanced features, and advanced technologies.
