- Non-life insurance is defined as any insurance not determined to be life insurance. It includes automobile and homeowners' policies and provides payments depending on the loss from a particular financial event. The market value is measured by the written premium generated by market players within a given year.

- The Austrian non-life insurance market recorded written premiums of \$11.9 billion in 2023, representing a compound annual growth rate (CAGR) of 3.7% between 2018 and 2023.

- The motor segment accounted for the market's largest proportion in 2023, with total written premiums of \$4.7 billion, equivalent to 39% of the market's overall value.

- The Austrian non-life insurance market is experiencing significant growth, driven by rising awareness of the importance of insurance in safeguarding assets and mitigating financial risks. Moreover, the growing elderly population is significantly boosting demand for health insurance policies, as aging individuals increasingly prioritize comprehensive coverage to manage rising medical expenses and long-term care needs. According to Eurostat, the population of individuals aged 65 and above in Austria reached 1.8 million in 2023, reflecting a 3.1% increase from the previous year.
