The market value is measured by the written premium generated by market players within a given year.
- The Brazilian non-life insurance market recorded written premiums of \$55.5 billion in 2023, representing a compound annual growth rate (CAGR) of 2.2% between 2018 and 2023.
- The motor segment accounted for the market's largest proportion in 2023, with total written premiums of \$11.6 billion, equivalent to 20.9% of the market's overall value.
- According to GlobalData, in 2023, Brazil held a market share of 68.1% of the South American non-life insurance market.
