The market value is measured by the written premium generated by market players within a given year.
- The Greek non-life insurance market recorded written premiums of \$2.6 billion in 2023, representing a compound annual growth rate (CAGR) of 2.5% between 2018 and 2023.
- The motor segment accounted for the market's largest proportion in 2023, with total written premiums of \$1.1 billion, equivalent to 41.1% of the market's overall value.
- According to GlobalData, in 2023, Greece held a market share of 0.4% of the European non-life insurance market.
