- The Mexican non-life insurance market recorded written premiums of \$26.6 billion in 2023, representing a compound annual growth rate (CAGR) of 11.3% between 2018 and 2023.
- The motor segment accounted for the market's largest proportion in 2023, with total written premiums of \$8.7 billion, equivalent to 32.6% of the market's overall value.
- According to GlobalData, in 2023, Mexico held a market share of 1.2% of the North American non-life insurance market.
