Summary

Key Highlights

- Non-life insurance is defined as any insurance not determined to be life insurance. It includes automobile and homeowners' policies and provides payments depending on the loss from a particular financial event. The market value is measured by the written premium generated by market players within a given year.
- The North American non-life insurance market recorded written premiums of \$2,298.7 billion in 2023, representing a compound annual growth rate (CAGR) of 8.4% between 2018 and 2023.
- The motor segment accounted for the market's largest proportion in 2023, with total written premiums of \$421.6 billion, equivalent to 18.3% of the market's overall value.
- The North American non-life insurance market is experiencing significant growth, driven by rising awareness of the importance of insurance in safeguarding assets and mitigating financial risks. This heightened awareness has led to an increase in the number of active non-life insurance policies. According to the Office of the Superintendent of Financial Institutions of Canada, in 2023, the number of active non-life insurance policies in the country reached 45.1 million, an increase of 1.6% from the previous year.
