Summary

- Non-life insurance is defined as any insurance not determined to be life insurance. It includes automobile and homeowners' policies and provides payments depending on the loss from a particular financial event. The market value is measured by the written premium generated by market players within a given year.
- The Peruvian non-life insurance market recorded written premiums of \$2.6 billion in 2023, representing a compound annual growth rate (CAGR) of 5.3% between 2018 and 2023.
- The property segment accounted for the market's largest proportion in 2023, with total written premiums of \$1.0 billion, equivalent to 38.5% of the market's overall value.
- The Peruvian non-life insurance market is experiencing significant growth, driven by rising awareness of the importance of insurance in safeguarding assets and mitigating financial risks. Additionally, natural catastrophes, such as floods and wildfires, continue to occur with significant impact, driving the demand for non-life insurance as they cause substantial damages and affect numerous individuals, highlighting the critical role of insurance in providing financial protection and supporting recovery efforts. According to the EM-DAT (Emergency Events Database) by the Centre for Research on the Epidemiology of Disasters (CRED), natural catastrophes in Peru affected 695,794 people and resulted in total damages of \$990.0 million in 2023.
