#### Summary

#### Key Highlights

- Non-life insurance is defined as any insurance not determined to be life insurance. It includes automobile and homeowners' policies and provides payments depending on the loss from a particular financial event. The market value is measured by the written premium generated by market players within a given year.
- The Russian non-life insurance market recorded written premiums of \$19.6 billion in 2023, representing a compound annual growth rate (CAGR) of 3.2% between 2018 and 2023.
- The motor segment accounted for the market's largest proportion in 2023, with total written premiums of \$7.7 billion, equivalent to 39.2% of the market's overall value.
- The contraction in the Russian non-life insurance market in 2023 was driven by declining disposable incomes. Higher taxes and stagnating wage growth reduced consumers' ability to spend on non-essential services, including insurance policies. According to Eurostat, the net household disposable income of Russia fell by 12.4% in 2023 compared to the previous year, reflecting economic pressures that deterred individuals and businesses from prioritizing voluntary insurance coverage.
