- Organic food refers to food products that are grown and produced using methods that avoid the use of synthetic pesticides, chemical fertilizers, genetically modified organisms (GMOs), and artificial additives. Market values considered based on retail selling price (RSP).
- The Singaporean organic food market recorded revenues of \$21.9 million in 2023, representing a compound annual growth rate (CAGR) of 3% between 2018 and 2023.
- The meat, fish & poultry segment accounted for the market's largest proportion in 2023, with total revenues of \$10.7 million, equivalent to 48.7% of the market's overall value.
- The growth of the Singaporean organic food market is driven by high disposable income and significant consumer spending on premium and higher-quality grocery products. According to the Singapore Department of Statistics (DOS), in 2023, the median household income from work among resident-employed households in Singapore reached \$10,869.0, up 7.6% over 2022.
