- The Italian Packaged water market had total revenues of \$8,129.2 million in 2023, representing a compound annual growth rate (CAGR) of 0.6% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.4% between 2018 and 2023, to reach a total of 14,182.7 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.3% for the five-year period 2023-28, which is expected to drive the market to a value of \$10,501.4 million by the end of 2028.
