- Market consumption volume increased with a CAGR of 4% between 2018 and 2023, to reach a total of 6,382.7 million liters in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 6.7% for the five-year period 2023-28, which is expected to drive the market to a value of \$8,219.5 million by the end of 2028.
