- Market consumption volume increased with a CAGR of 3.4% between 2018 and 2023, to reach a total of 59,866.3 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.4% for the five-year period 2023-28, which is expected to drive the market to a value of \$63,145.6 million by the end of 2028.
