- The Spanish Packaged water market had total revenues of \$4,256.8 million in 2023, representing a compound annual growth rate (CAGR) of 6.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 3.3% between 2018 and 2023, to reach a total of 7,344.6 million liters in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 5.6% for the five-year period 2023-28, which is expected to drive the market to a value of \$5,585.0 million by the end of 2028.
