- The Turkish Packaged water market had total revenues of \$2,073.8 million in 2023, representing a compound annual growth rate (CAGR) of 1.5% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.7% between 2018 and 2023, to reach a total of 5,492.4 million liters in 2023.
- The performance of the market is forecast to decline, with an anticipated CAGR of -10.9% for the five-year period 2023-28, which is expected to drive the market to a value of \$1,162.3 million by the end of 2028.
