- Within the transportation services industry, China is the leading country among the top 5 emerging nations, with market revenues of \$13,42,835.9 million in 2023. This was followed by India and Brazil with a value of \$1,62,359.9 and \$1,17,167.6 million, respectively.
- China is expected to lead the transportation services industry in the top five emerging nations, with a value of \$18,81,837.9 million in 2028, followed by India and Mexico with expected values of \$1,86,758.1 and \$1,43,867.7 million, respectively.
