- The South Korean travel & tourism industry recorded revenues of \$84.2 billion in 2023, representing a negative compound annual growth rate (CAGR) of 0.8% between 2018 and 2023.
- The travel intermediaries segment accounted for the industry's largest proportion in 2023, with total revenues of \$41.0 billion, equivalent to 48.7% of the industry's overall value.
- In 2023, the industry experienced a significant value increase, recovering from recent declines, primarily driven by increasing capital investment, particularly in sectors such as airlines, railways, foodservice, and accommodation. Investors are channelling more funds into expanding travel infrastructure to meet rising demand. According to the World Bank, the capital investment in travel and tourism in South Korea reached \$14.8 billion in 2023, reflecting a 4.6% increase from 2022.
