# **Key Market Drivers**

## **Technological Advancements**

Time-lapse imaging involves continuous monitoring of embryos using specialized incubators equipped with cameras. This technology allows embryologists to observe the development of embryos in real-time without disturbing the incubation environment. It provides valuable information about embryo viability, leading to improved embryo selection and increased success rates. Preimplantation Genetic Testing (PGT) involves the screening of embryos for genetic abnormalities before implantation. There are different types of PGT, including PGT-A (aneuploidy screening), PGT-M (monogenic/single-gene disorders), and PGT-SR (structural rearrangements). PGT helps identify chromosomally normal embryos, reducing the risk of genetic disorders and increasing the chances of a successful pregnancy. Intracytoplasmic Sperm Injection (ICSI) involves the direct injection of a single sperm into an egg, enhancing fertilization rates, especially in cases of male infertility. This technique has become a standard part of many IVF procedures, contributing to the treatment's success. Vitrification is a fast-freezing technique that prevents ice crystal formation, preserving the structural integrity of eggs and embryos. This technology has significantly improved the success rates of egg and embryo freezing, allowing individuals to preserve their fertility for future use. Al and machine learning applications are being integrated into IVF laboratories to analyze large datasets related to embryo development, patient outcomes, and treatment protocols. These technologies assist in predicting optimal conditions for embryo culture, refining treatment plans, and personalizing fertility care. Advancements in biopsy techniques for obtaining genetic material from embryos have improved the accuracy and safety of PGT. Techniques like trophectoderm biopsy, where cells are extracted from the outer layer of the embryo, have become more common. Next-Generation Sequencing (NGS) is used in PGT for analyzing the genetic material of embryos with high precision. It allows for comprehensive genetic screening, providing detailed information about the chromosomal makeup of embryos.

These specialized pumps are used in the egg retrieval process during IVF. Advanced ovum aspiration pumps contribute to the efficiency of the procedure, minimizing trauma to eggs and optimizing the chances of successful fertilization. Improvements in cryopreservation techniques, including the use of cryoprotectants and controlled cooling rates, have enhanced the survival rates of frozen eggs, sperm, and embryos. This has expanded options for fertility preservation and storage. In certain cases of mitochondrial disorders, a small amount of mitochondrial DNA from a healthy donor is used to replace defective mitochondria in the mother's egg. This technique aims to prevent the transmission of mitochondrial diseases to offspring. This factor will help in the development of the UAE In-Vitro Fertilization (IVF) Market.

# **Increasing Awareness**

As awareness increases, individuals and couples become more informed about fertility issues and the various factors that can contribute to infertility. In September 2024, the "Fertility Your Way" campaign, a collaboration between UAE-based femtech startup Ovasave and Merck Gulf, gained significant traction in Dubai and Abu Dhabi. Supported by Dubai Investments and Fakeeh University Hospital, the initiative featured a mobile screening bus that offered over 500 free AMH tests at key locations, including workplaces, from September 16 to 25. This campaign is part of a wider movement to raise awareness about fertility issues and empower women to take control of their reproductive health. Increasing awareness like this is driving the growth of the UAE's In-Vitro Fertilization (IVF) market by encouraging open discussions and providing women with the tools to make informed decisions about their fertility. Awareness campaigns through various media channels, including television, radio, social media, and healthcare websites, reach a broad audience. These campaigns help disseminate information about fertility treatments, creating a higher demand for services like IVF. When public figures share their experiences with fertility treatments, including IVF, it can significantly impact public perception. Celebrity endorsements and stories reduce the sense of isolation around fertility struggles and inspire others to consider similar treatments. In November 2023, the UAE introduced significant reforms to fertility regulations, including relaxed laws surrounding IVF and egg freezing for non-Muslim, unmarried couples, and the lifting of the surrogacy ban. The updated legislation now allows unmarried non-Muslim couples to undergo IVF treatment, provided the eggs and sperm come from the couple. These legal changes have also established clear guidelines for the use of embryos and eggs in assisted reproductive procedures. As awareness of these new laws spreads, there is a growing acceptance of fertility treatments, driving the expansion of the UAE's In-Vitro Fertilization (IVF) market. These changes are encouraging more individuals to explore IVF options, boosting demand for these services.

Support groups and forums where individuals share their experiences with fertility treatments can contribute to increased awareness. These platforms provide a sense of community and encouragement for those considering or undergoing IVF. The availability of accurate and easily accessible information online allows individuals to research and understand fertility treatments. According to the International Labour Organization (ILO), female labor force participation in the Arab world has risen from 16% in 1990 to over 18% in 2019, with notable increases in the GCC countries. In the UAE, the rate jumped from 28% to 52%, and other countries like KSA and Oman saw similar progress. Education and career development often take precedence, leading to delayed childbearing as individuals and couples prioritize professional goals. Increased focus on women[s empowerment and gender equality has resulted in more women pursuing careers and higher education before starting families. This shift contributes to later pregnancies, increasing demand for fertility treatments. As awareness of age-related fertility challenges grows, individuals are more likely to seek IVF when natural conception proves difficult. In the UAE, fertility has dropped significantly, from 6.7 children per woman in 1960 to around 1.4 in 2022, prompting individuals to explore IVF as an option. Evolving social norms also support delayed childbearing, particularly in women[s 30s and 40s, further driving demand for fertility treatments. Economic factors, such as financial stability, also contribute to delayed family planning, increasing reliance on treatments like IVF when couples decide to conceive. Modern lifestyles, including stress, sedentary habits, and environmental factors, further impact fertility, leading individuals to seek medical solutions such as IVF.

Advances in IVF technology have made the procedure more accessible and effective. As individuals and couples become aware of the success rates and advancements in fertility treatments, they are more inclined to consider IVF as a viable option. Greater social acceptance of assisted reproductive technologies, including IVF, has reduced stigma around seeking fertility treatments. This acceptance encourages individuals and couples to explore these options when facing difficulties conceiving. Globalization and cultural influences contribute to changing perspectives on family planning. Individuals may adopt family planning practices influenced by diverse cultural norms, impacting the timing of when they decide to have children. This factor will accelerate the

Fertility specialists can discuss medication protocols, address any concerns, and electronically prescribe medications, streamlining the process for patients. In certain cases, telemedicine allows for remote monitoring of patients undergoing IVF treatments. Patients may use connected devices or apps to provide data such as hormone levels or cycle progress, allowing healthcare providers to monitor and adjust treatment plans as needed. Telemedicine extends beyond individual consultations to include educational webinars, online resources, and virtual support groups. This approach helps in disseminating
