In addition to these, there are 182 private hospitals, primarily situated in urban areas), and rising demand for advanced medical technologies. The Vietnam Medical Devices Market is characterized by a growing demand for modern healthcare solutions driven by factors such as an aging population, rising chronic diseases, and increasing healthcare awareness. The market is witnessing investments in research and development, partnerships with international manufacturers, and government initiatives to improve healthcare infrastructure, which collectively contribute to its expansion. Advancements in technology and regulatory reforms further shape the landscape, fostering innovation and competitiveness within the industry.

## Key Market Drivers

### Government Initiatives and Healthcare Reforms

Vietnam's government has embarked on a multifaceted approach to elevate the nation's healthcare system, marked by a series of strategic initiatives and comprehensive reforms. In 2022, Vietnam's Ministry of Health (MoH) received approval from the National Assembly (NA) and the government to utilize social resources for medical examinations and treatments. This enables medical facilities to secure capital for investments in infrastructure, medical equipment, and other expenses. Additionally, they can accept sponsorships and aid from both domestic and international organizations and individuals. These endeavors encompass a spectrum of measures aimed at bolstering the quality, accessibility, and efficiency of healthcare services across the country. Paramount among these efforts is the substantial augmentation of healthcare spending, indicative of the government's unwavering commitment to prioritizing the well-being of its citizens.

Aligned with this commitment is a concerted focus on enhancing healthcare infrastructure throughout Vietnam. For example, Malaysia's IHH Healthcare, one of Asia's largest hospital groups, is exploring opportunities to enter the Vietnamese market through acquisitions. Competitors have already begun entering Vietnam via acquisitions. In October 2023, Singapore's Raffles Medical Group announced it would acquire a majority stake in the American International Hospital in Ho Chi Minh City.

Additionally, Thomson Medical entered the market by acquiring the country's largest private hospital, Far East Medical Vietnam, for USD 382 million in 2023. This encompasses the construction, renovation, and expansion of healthcare facilities, including hospitals, clinics, and medical centers, particularly in underserved regions. By fortifying the physical infrastructure of the healthcare system, the government aims to ensure that all segments of the population have equitable access to quality healthcare services, irrespective of geographical constraints.

In tandem with investments in infrastructure, the government has also embarked on a rigorous endeavor to fortify the regulatory frameworks governing the healthcare sector. Recognizing the pivotal role of robust regulations in safeguarding patient safety, promoting innovation, and fostering industry growth, Vietnam has implemented measures to enhance regulatory oversight, compliance, and quality assurance across the medical device ecosystem. These efforts are pivotal in instilling confidence among stakeholders, including healthcare providers, manufacturers, and patients, thereby fostering a conducive environment for sustainable growth and development within the medical devices market.

### Growing Healthcare Expenditure

Vietnam's burgeoning healthcare expenditure reflects a broader narrative of economic growth and expanding investments in healthcare infrastructure, underpinned by both public and private stakeholders. This upward trajectory in healthcare spending is emblematic of Vietnam's commitment to prioritizing the well-being of its populace and catalyzing advancements in healthcare delivery. As reported by the Economist Intelligence Unit (EIU), Vietnam's healthcare expenditure reached approximately USD 18.5 billion in 2022, accounting for 4.6% of the country's GDP. This growing investment in healthcare underscores the country's increasing focus on improving medical infrastructure and services, presenting opportunities for the eye care sector to expand and meet the rising demand for vision-related treatments and innovations.

A pivotal driver of this trend is the sustained economic growth experienced by Vietnam in recent years, which has enabled the country to allocate greater resources towards healthcare initiatives. As the economy continues to flourish, propelled by factors such as industrialization, urbanization, and foreign direct investment, the government and private sector alike are increasingly inclined to channel resources towards bolstering the nation's healthcare system. This includes investments in healthcare facilities, medical personnel, and crucially, medical devices that are instrumental in delivering quality care to patients.

The rising affluence within Vietnamese society has engendered a shifting paradigm in healthcare consumption patterns. With increasing disposable incomes and a burgeoning middle class, there is a palpable uptick in the demand for healthcare services and products among the populace. This newfound prosperity has instilled a growing willingness among individuals to allocate a greater portion of their income towards healthcare expenditures, including preventive care, diagnostics, and treatment modalities. Consequently, there is a heightened demand for advanced medical equipment and technologies that offer superior efficacy, accuracy, and patient outcomes.

### Aging Population and Rising Chronic Diseases

Vietnam is undergoing a profound demographic transition characterized by a rapid aging of its population (By 2024, the elderly population in the country is projected to exceed 21 million, representing nearly 20 percent of the total population. In 2019,

individuals aged 60 and above constituted 11.9 percent of the population. This epidemiological transition underscores the urgent need for effective strategies to diagnose, treat, and manage chronic diseases, while simultaneously mitigating their societal and economic burdens.

In response to these imperatives, there is a burgeoning demand for medical devices tailored to the specific needs of patients with chronic conditions. Diagnostic devices play a pivotal role in early detection and monitoring, enabling healthcare providers to assess disease progression and tailor treatment regimens accordingly.
