In February 2024 the Minister of Economy convinced the CEO of the Central Bottling Company to delay planned price increases, as part of broader efforts to mitigate the impact of rising costs on consumers. However, in April 2024, the Central Bottling Company informed retailers of a 4.5% price hike for its soft drinks, citing increased costs for materials and imports. Shortly after, in May 2024, Tempo announced a price incre...
