Value sales continued to be relatively low for meals and soups in Algeria in 2024 and with most offerings being imported, they are too expensive for the average consumer. Significant depreciation of the Algerian dinar over recent years has also made imported brands even more expensive. As such, meals and soup registered minimal volume growth. Dry soup continued to account for most value sales.
