- The systems & ordnance segment accounted for the sector's largest proportion in 2023, with total revenues of \$516.5 million, equivalent to 44.8% of the sector's overall value.
- On April 4, 2023, Finland formally joined NATO as its 31st member. This participation has enhanced Finland's defense connections with other NATO members and increased cooperation on defense issues.
