- The systems & ordnance segment accounted for the sector's largest proportion in 2023, with total revenues of \$9,685.1 million, equivalent to 46.6% of the sector's overall value.
- In 2023, Saudi Arabia accounted for a 37.6% share in the Middle Eastern aerospace & defense sector. It was followed by the UAE with a share of 23.5%.
