The scope includes components sold through fast fits, auto centres, garages, tyre specialists, vehicle manufacturer networks, petrol stations, hypermarkets, crash repair centres/body shops, online sales, parts & accessories stores, and others. Both internal combustion engines and electric vehicles are considered in our scope. Our analysis encompasses both passenger cars and light commercial vehicles.
- The Chinese automotive aftermarket sector recorded revenue of \$142 billion in 2023, representing a compound annual growth rate (CAGR) of 4.0% between 2018 and 2023.
- Sector consumption volume increased with a CAGR of 5.6% between 2018 and 2023, to reach a total of 2,977.5 million units in 2023.
- China holds the largest automotive aftermarket in the Asia-Pacific region, capturing a significant 46.6% share in 2023.
