The scope includes components sold through fast fits, auto centres, garages, tyre specialists, vehicle manufacturer networks, petrol stations, hypermarkets, crash repair centres/body shops, online sales, parts & accessories stores, and others. Both internal combustion engines and electric vehicles are considered in our scope. Our analysis encompasses both passenger cars and light commercial vehicles.
- The Indian automotive aftermarket sector recorded revenue of \$24.5 billion in 2023, representing a compound annual growth rate (CAGR) of 3.0% between 2018 and 2023.
- Sector consumption volume increased with a CAGR of 3.5% between 2018 and 2023, to reach a total of 763.4 million units in 2023.
- India captured a share of 8.0% in the Asia-Pacific automotive aftermarket sector in 2023.
