- Cryptocurrency market is a decentralized financial system that operates without oversight or regulation from any central authority, such as a government, and functions independently through a distributed network. Cryptocurrencies can be bought and sold via exchanges and stored in 'wallets'. Unlike traditional currencies, cryptocurrencies exist only as a shared digital record of ownership, stored on a blockchain. Market value is described by market capitalization. Market volume refers to the total trading volume of cryptocurrencies over the span of a year. Market share refers to the approximate trading volume handled by a specific cryptocurrency exchange.
- The global cryptocurrency market recorded market capitalization of \$1,115.1 billion in 2023, representing a compound annual growth rate (CAGR) of 32.8% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 73.1% between 2018 and 2023, to reach a total of 76,750 billion trading volume USD in 2023.
- The market growth during 2018-23 can be attributed to the increased adoption of blockchain technology, institutional investments, decentralized finance (DeFi) growth, technological advancements, and global remittances and cross-border payments.
