Key Highlights

- The ice cream market consists of artisanal ice cream (both dairy and water-based), impulse ice cream (includes single-serve ice cream tubs, packaged cones ice cream sandwiches, and chocolate-coated ice creams) and take-home ice cream (includes multiple-serving ice cream tubs and, ice-cream cakes). The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2023 exchange rates.
- The Swiss Ice Cream market had total revenues of \$788.6 million in 2023, representing a compound annual growth rate (CAGR) of 6.4% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 5.4% between 2018 and 2023, to reach a total of 48.1 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 7.8% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$1,149.6 million by the end of 2028.
