- The Chinese Meat market had total revenues of \$274,976.2 million in 2023, representing a compound annual growth rate (CAGR) of 2.8% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2% between 2018 and 2023, to reach a total of 34,245.5 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 1.9% for the five-year period 2023-28, which is expected to drive the market to a value of \$302,506.4 million by the end of 2028.
