Summary

- The meat market consists of the retail sales of ambient meat, chilled raw packaged meat - processed, chilled raw packaged meat - whole cuts, cooked meats - counter, cooked meats - packaged, fresh meat (counter) and frozen meat. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The South African Meat market had total revenues of \$6,741.2 million in 2023, representing a negative compound annual growth rate (CAGR) of 4.5% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 2.3% between 2018 and 2023, to reach a total of 1,622 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 1.3% for the five-year period 2023-28, which is expected to drive the market to a value of \$7,198.3 million by the end of 2028.
