- The Japanese PCs market recorded revenues of \$15,937.4 million in 2023, representing a compound annual growth rate (CAGR) of 3.1% between 2018 and 2023.
- The portable pcs segment accounted for the market's largest proportion in 2023, with total revenues of \$12,376.4 million, equivalent to 77.7% of the market's overall value.
- Japan accounted for a 20.3% share of the Asia-Pacific PCs market in 2023.
