- The Brazilian Syrups & Spreads market had total revenues of \$1,364.6 million in 2023, representing a compound annual growth rate (CAGR) of 1.4% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.7% between 2018 and 2023, to reach a total of 139 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.3% for the five-year period 2023-28, which is expected to drive the market to a value of \$1,684.3 million by the end of 2028.
