- The Mexican Syrups & Spreads market had total revenues of \$1,789.7 million in 2023, representing a compound annual growth rate (CAGR) of 8% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.3% between 2018 and 2023, to reach a total of 275.2 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 6.3% for the five-year period 2023-28, which is expected to drive the market to a value of \$2,426.3 million by the end of 2028.
