- The Syrups & Spreads market consists of retail sale of jams, jellies & preserves, molasses, savory spreads, syrups and sweet spreads. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2023 exchange rates.
- The Singaporean Syrups & Spreads market had total revenues of \$101.9 million in 2023, representing a compound annual growth rate (CAGR) of 5.5% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.7% between 2018 and 2023, to reach a total of 11.5 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.5% for the five-year period 2023-28, which is expected to drive the market to a value of \$120.8 million by the end of 2028.
