- The South African Syrups & Spreads market had total revenues of \$213.6 million in 2023, representing a compound annual growth rate (CAGR) of -0.6% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.2% between 2018 and 2023, to reach a total of 47.9 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.6% for the five-year period 2023-28, which is expected to drive the market to a value of \$255.5 million by the end of 2028.
