- Market consumption volume increased with a CAGR of 1.7% between 2018 and 2023, to reach a total of 192.5 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.7% for the five-year period 2023-28, which is expected to drive the market to a value of \$2,025.0 million by the end of 2028.
