The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2023 exchange rates.
- The Turkish Syrups & Spreads market had total revenues of \$763.8 million in 2023, representing a compound annual growth rate (CAGR) of 0.2% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 4.1% between 2018 and 2023, to reach a total of 306.1 million kilograms in 2023.
- The performance of the market is forecast to decline, with an anticipated CAGR of -6.2% for the five-year period 2023-28, which is expected to drive the market to a value of \$556.0 million by the end of 2028.
