- The Belgian transportation services industry has experienced slow growth in 2023, influenced by high inflation and a slowdown in real GDP growth. According to the National Bank of Belgium, the real GDP growth in Belgium was 1.5% in 2023, the lowest growth in three years, after a 3.0% increase in 2022.
