- According to GlobalData, in 2023, the Hong Kongese transportation services industry grew 3.2% annually. The growth is attributed to the rising globalization and the steady increase in exports. According to the World Trade Organization (WTO), in 2023, Hong Kongese exports reached \$754.5 billion, up 5.8% annually.
