- The Swiss transportation services industry has experienced negative growth in 2023, influenced by high inflation and a slowdown in real GDP growth. According to the Federal Council of the Swiss Government Switzerland's real GDP growth for 2023 was 0.7%, a significant decline from the 2.5% growth recorded in 2022.
