While there was a double-digit percentage value increases in both current and constant value sales in air care in Bolivia in 2024, volume growth was much more modest, as significant price rises dampened volume sales. This was particularly for imported brands, where a severe shortage of US dollars, owing to falling foreign reserves arising from declining gas production and mounting debt levels, led to hefty price rises.
