Following two years of significant hikes driven by the devaluation of the local currency (the colon - CRC) and rising raw material costs, air care saw a more modest increase in unit price during 2024. While the rate of growth in retail current value sales of air care slowed to single digits in 2024, there was a modest pickup in the rate of growth in retail volume sales, which had been little better than static the previous year.
