Following strong retail selling price (RSP) growth in 2023, mostly driven by inflation, full-service restaurants registered a slight RSP decline in 2024. This was due to several factors. Firstly, prices stabilised but remained very high, and secondly, local consumers became more conservative with their spending. These two factors resulted in a shift from full-service restaurants to limited-service restaurants in 2024. Indeed, fast-casual, premium/gourmet limited-service restaurants could compete...
