In 2024, overall, health and beauty specialists in Canada posted a strong, if slower, increase in retail current value sales amid a marginal rise in the number of outlets. However, there was some divergence in performance, with optical goods stores registering a decline in both retail current value sales and outlets. Meanwhile, health and personal care stores saw a drop in terms of outlet number. However, the other categories all recorded positive growth in retail current value sales and outlet...
