The colder and wetter spring and summer in 2024 put negative pressure on sales of home insecticides in the Netherlands. The reduced presence of insects due to the unfavourable weather conditions led to lower consumer demand for insecticide products, as fewer households dealt with significant infestations. Dutch consumers, who are generally not accustomed to severe insect problems, had even less reason to purchase home insecticides during these seasons, thus curbing sales.
