This was particularly for imported brands, where a severe shortage of US dollars, owing to falling foreign reserves arising from declining gas production and mounting debt levels, led to price rises. This impacted metal and shoe polish in particular, as they are mainly imported, whereas there is significant offerings of local economy brands of furniture and floor polish.
