Retail value sales of polishes decreased in both current and constant value sales during both 2024 and the review period as a whole. Although demand was supported by an improving economic environment (most notably a reduction in inflation) and a reduction in smuggling from neighbouring Argentina during 2024, all segments of polishes saw sales decline during the year. This was because new lifestyle habits have negatively affected polishes to a much greater extent than other home care categories.
