These threads are inserted underneath the skin using a needle or cannula to emulate a lifting effect and trigger collagen production. Aesthetic threads, including absorbable or non-absorbable sutures, are typically made of biocompatible materials such as polydioxanone (PDO), poly-L-lactic acid (PLLA), or polypropylene. Aesthetic threads come in various forms, such as smooth mono threads, barbed or notched cog threads, or spiral threads, which anchor into the tissues to pull and lift the skin. As a result, these threads are extensively used in the face, neck, and other body parts, depending on the treatment goals. Some of the advantages of aesthetic thread include less invasive alternative to surgical facelifts, reduced risks and downtime, natural-looking and subtle skin enhancements, minimal scarring or visible marks, and long-term benefits.

The global market is primarily driven by the augmenting demand for minimally invasive aesthetic procedures. This can be attributed to the shifting consumer preference from expensive traditional facelift surgeries to comparatively inexpensive non-surgical alternatives.
