Market value refers to the revenue generated by law firms in a year for the services they provide, including all relevant taxes. Market volume represents the total number of legal professionals in a country during a specific year.
- The Swedish legal services market recorded revenues of \$3.1 billion in 2024, representing a compound annual growth rate (CAGR) of 5.9% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 0.8% between 2019 and 2024, to reach a total of 15.0 thousand personnel in 2024.
- The Swedish market growth during 2019-24 is attributed to economic growth, the growing affordability of legal services backed by increasing income levels and employment, and the rising demand for legal services among individuals, businesses, and government entities. For instance, according to Statistics Sweden, nominal gross value added (GVA) in services in Sweden grew by 1.1% and 1.7% in 2023 and 2024, respectively.
