The market is segmented into inpatient care, outpatient care, long-term care, medical goods, and collective services and capital formation.
- The Hong Kongese healthcare providers market recorded revenues of \$38.1 million in 2024, representing a compound annual growth rate (CAGR) of 11.0% between 2019 and 2024.
- The inpatient care segment accounted for the market's largest proportion in 2024, with total revenues of \$12.6 million, equivalent to 33.0% of the market's overall value.
- The growth of the Hong Kongese healthcare providers market is driven by the mounting aging population. According to the World Bank, in 2023 (the latest available data), the percentage of the total population aged 65 or above in Hong Kong reached 22%, up from 21% in 2022. This is increasing the demand for long-term medical care and, therefore, healthcare services.
