- According to GlobalData, in 2024, the Indonesian healthcare providers market grew by 4.2% annually. The growth is attributed to rapid urbanization, which has driven the demand for more urban healthcare infrastructure and services, including specialized hospitals and outpatient clinics. According to the World Bank, in 2024, the urban population in Indonesia reached 165.8 million, up 2.0% annually.
